Dear Sir/Madam,

I write in response to your letter dated the 10th April 2024 and in accordance with the Section 37F request made by the Board, Bord na Móna Powergen Limited (the applicant), has published the statutory notices and given notice to Mayo County Council and the relevant prescribed bodies that significant additional information has been furnished to An Bord Pleanála in respect of the proposed Oweninny Wind Farm Phase 3 development.

I confirm that the following has been carried out in accordance with items 'a' and 'b' from the Section 37F request:

Request Item (a)

"publish in one or more newspapers circulating in the area in which the proposed development would take place a notice stating that significant additional information in relation to the said effects has been furnished to the Board, that the additional information will be available, for inspection or for purchase (upon payment of a specified fee not exceeding the reasonable cost of making a copy), at a specified place and at specified times during a specified period, and that submissions or observations in relation to the additional information may be made in writing to the Board before a specified date (which shall not be less than 30 days), and update the stand-alone website stating that the additional information can be downloaded, and

The Board would also request that site notices be erected in this regard."

Applicant response:
